Limits that apply to other 8(a) companies do not apply to ANCs however a procurement may not be removed from planned competition to sole source it to an ANC-owned firm.	
<b>Non-Protestable 13 CFR 124.517(a)</b> Contracts awarded directly to an 8(a) certified ANC cannot be protested. The ability to fast track an important procurement is a huge benefit to the process, for Contracting and for the end users.	
<b>Rapid Procurement Process</b> The SBA ANC 8(a) contracting method avoids a long, expensive and complex procurement cycle and is significantly faster than any other means of contracting.
