Alaska Native Company (ANC) 8(a) certified companies can be awarded sole-source contracts with no competition and no competitive threshold dollar limitation on the contract amount. Limits that apply to other 8(a) companies do not apply to ANCs however a procurement may not be re- moved from planned competition to sole source it to an ANC-owned firm.

Non-Protestable 13 CFR 124.517(a) Contracts awarded directly to an 8(a) certified ANC cannot be protested. The ability to fast track an important procurement is a huge benefit to the process, for Contracting and for the end users.
